- 2. One-half of these Class B Units vest as follows: 25% vested on August 31, 2016, and the remaining 75% vest in 36 substantially equal monthly installments thereafter, subject to reporting person's continuous service as of each vesting date. The remaining half of these Class B Units vest upon completion of the issuer's Recapitalization and consummation of the issuer's initial public offering.
- 3. These Class B Units have no expiration date.
